women voters in burqa or purdah.
In a statement, the poll authority
said to encourage participation of
'purdanasheen' (in burqa or purdah)
women, "special arrangements" will
be made at the polling stations as per
its instructions for their "dignified
identification" in the presence of lady
polling officers or attendants while
ensuring their privacy.

Addressing a press conference here on Monday to announce

schedule for Bihar elections, Chief Election Commissioner Gyanesh Kumar had said Aanganwadi workers will be present at all polling booths in Bihar to help verify the identity of burqa-clad voters.

Responding to a question about 'ghungat' and burqa clad women during a press conference, Kumar said there are clear guidelines of the Election Commission about the verification of identity inside polling booths and they will be strictly followed. "Our anganwadi workers will be deployed at all polling booths for verifying the identity of burqaclad women.

The guidelines of the commission are very clear about this — that how identity is verified inside a polling station and they will be strictly followed," he said.

On Thursday, the poll authority had said up to 90,712 Anganwadi Sevikas will be deployed on poll duty.

Bihar BJP president Dilip Jaiswal had on Saturday last urged the Commission to ensure that faces of women turning up at booths in burgas were tallied with voter cards.

The elections for 243 assembly constituencies in Bihar will be held in two phases — November 6 and 11 — while the counting of votes will be on November 14.

Focusing on transparency, accountability, and technological innovation, the state has implemented numerous structural reforms in mineral administration, resulting in Chhattisgarh becoming one of the leading mining states in the country. New discoveries in the state, including world-class iron ore, coal, limestone, bauxite, and tin ore, have demonstrated the availability

of critical, strategic, and rare earth minerals, strengthening the state's global reputation.

Chhattisgarh's mining sector contributes approximately 10 percent to the state's GDP, while its share in the country's total mineral production is approximately 17 percent. The state's mineral revenue has increased 34-fold in 25 years. While mineral revenue was only ₹429 crore at the time of state formation, it increased to ₹14,592 crore in 2024-25. This achievement is the result of the state's robust mineral policy and continuous administrative reforms.

Under the Mineral Auction Rules 2015, established under the Mines and Minerals (Development and Regulation) Act, 1957, as amended in 2015, 60 mineral blocks have been successfully auctioned in the state so far. These include 15 iron ore, 14 bauxite, 18 limestone, and 13 critical and strategic mineral blocks. The auction process for five new blocks (two limestone, one iron ore, one gold, and one base metal block) has also been initiated.

The Directorate of Geology and Mining, Chhattisgarh, has signed MoUs with IIT Mumbai, IIT (ISM) Dhanbad, Chief Minister Vishnu Deo Sai said that mineral wealth is not just an economic source, but the foundation for the state's all-round development. Chhattisgarh has presented an ideal administrative model through coordinated efforts towards policy reforms, digital transparency, and sustainable development in the mining sector. This progress of the state is not only a sign of economic strength but also a lasting step towards public interest-based development.

and Coal India Limited for long-term collaboration in the field of mining research and exploration. This partnership has accelerated the scientific exploration of critical and strategic minerals.

In accordance with the Prime Minister's Mineral Area Welfare Scheme Guidelines 2024, the District Mineral Foundation Trust Rules, 2025, have been notified in the state. So far, the state has received contributions of ₹16,119 crore, under which 105,653 works have been approved, of which 74,454 have been completed. DMF Portal 2.0 has been implemented to ensure transparency in financial approval, monitoring, and management.

The Mineral Online 2.0 portal, developed by the Mineral Department, has fully digitised the state's mineral administration. The system is secure, multi-functional, and user-friendly, promoting

transparency and efficiency. This initiative is establishing Chhattisgarh as a national model state in mining management. In accordance with the principles of ease of doing business, the allocation of sand mines in the state is now being done through a completely online system. An MoU has been signed with MSTC for this purpose. The new system eliminates human intervention, making the entire process transparent, fair, and secure.

Under the Star Rating System implemented under the Minor Minerals Rules, 2015, mines are being evaluated on standards of mining, environmental management, safety measures, and sustainable development. Under this system, three mines have been awarded 5-star ratings and 32 mines have been awarded 4-star ratings, a testament to the state's commitment to scientific and responsible mining.

Rs 1.84 Lakh Crore in Unclaimed Financial Assets, Sitharaman Urges Claim

Ahmedabad: Union Finance Minister Nirmala Sitharaman on Saturday October 4, 2025 said financial assets worth Rs 1.84 lakh crore were lying unclaimed with banks and regulators, and officials need to ensure these reach the rightful owners.

Sitharaman launched the threemonth Apki Poonji, Apka Adhikar (Your Money, Your Right) campaign from Gandhinagar in the presence of Gujarat Finance Minister Kanubhai Desai and senior officials from the banks and the finance ministry.

Speaking on the occasion, the Union Minister for Finance and Corporate Affairs said that financial assets worth Rs 1.84 lakh crore were lying unclaimed with banks and regulators in the form of bank deposits, insurance, provident fund or shares.

She urged officials to work on three As Awareness, Access and Action to ensure these unclaimed assets reach rightful owners during the three-month-long campaign.

"Unclaimed monies are lying with the banks or with the RBI or with the IEPF (Investor Education and Protection Fund). We have to find the rightful owners and claimants of those funds and hand the money over to them," Sitharaman said.

"As per the DFS (Department of Financial Services), Rs 1,84,000 crore is lying there. It is safe. I can assure you it is absolutely safe. You come when you want with proper papers. Money will be given to you. The government is the custodian for it. It can be through the bank or through SEBI. It can be through any other agency. But it is lying

there in safe custody," she assured. If the asset remains unclaimed for a long time due to any reason, it gets transferred from one entity to another, the minister said. From banks, it goes to the RBI in case of deposits, and in case of stocks or similar assets, it goes from SEBI to "another centre or the IEPF", she said.

"The RBI has created the UDGAM (Unclaimed Deposits Gateway To Access Information)

portal. So, it is moving from one unclaimed area to another, which is holding this unclaimed deposit. The moment you claim it, you get it. So, I honestly think it is high time that all of us spread the word to everyone," Sitharaman said. On the 'awareness' front, the minister urged government and bank officials to create awareness among people so that they come forward and claim their rightful assets, such as insurance policies lying unclaimed despite maturity.

"The first A is awareness. Build awareness. Tell them that your money is lying there, come with this document and take it. You can become ambassadors and tell people if they have yet to claim their rightful asset. Just ask them to find the papers and register on the portal," she said.

The minister further spoke about extending "access" to those rightful claimants, either through RBI's UDGAM portal or stalls created by banks for this purpose. "The third A is action, where you (officials) act on whatever you have, like small bits of papers," she said, adding that a "concerted attempt" will make the campaign successful.

Sitharaman said that it was Prime Minister Narendra Modi who persuaded her and the ministry to "move from one place to another and call up people asking them to claim their dues. So, bridge the gap and make sure people can take it."

Sitharaman also lauded the Gujarat Gramin Bank for assuring her that its officials would visit every village in the state to look for rightful owners of unclaimed deposits lying in the bank.

In a social media post, PM said India welcomes such moves and will continue to strongly support all efforts towards a durable and just peace in the region.

"We welcome President Trump's leadership as peace efforts in Gaza make decisive progress. Indications of the release of hostages mark a significant step forward. India will continue to strongly support all efforts towards a durable and just peace," PM said in a post on X.

The statement comes shortly after Trump ordered Israel to stop bombing the Gaza Strip after Hamas said it had accepted some elements of his 12-point plan to end the nearly two-year war and return all the remaining hostages taken in the October 7, 2023, attack. Hamas said it was willing to release the hostages and hand over power to other Palestinians, but that other aspects of the plan require further consultations among Palestinians.

On Tuesday PM had said Trump's comprehensive




plan to end the Gaza conflict provides a viable pathway to long term and sustainable peace between the Palestinian and Israeli people, as also for the larger West Asian region.

Chhattisgarh: Shah Rules Out Talks With Naxals

Union Home Minister Amit Shah On Saturday Ruled Out Talks With The Maoists And Asked Them To Surrender By March 31, 2026, Or Face Intensified Operations: Reports



Raipur: Union home minister Amit Shah on Saturday October 4, 2025 ruled out talks with the Maoists and asked them to surrender by March 31, 2026, or face intensified operations.

Addressing the Bastar Dussehra Lokotsav and Swadeshi Mela at Jagdalpur, headquarters of Bastar in Chhattisgarh, Shah reiterated his assertion that Naxalism will be rooted out of the country by March 31, 2026, and exhorted

the Maoists to surrender by the deadline.

"Some people have called for talks (with Naxals). What is there to talk about? The Chhattisgarh government has framed a lucrative surrender and rehabilitation policy for Naxals. Lay down your arms and join the mainstream." Shah exhorted the Naxals. He said that the Chhattisgarh government and the Centre are committed to development

across Bastar and all Naxal-affected areas.

The Union minister regretted that some people in Delhi have been spreading misinformation for years that backwardness breeds Naxalism and the Maoists are fighting for development. "But the fact is that Naxalism is the root cause of the backwardness of a region. Bastar has been deprived of development because of Naxalism," he added.

The Union home minister pointed out that today, basic amenities like roads, electricity, drinking water and toilets in every house and welfare schemes like ₹5 lakhs health insurance and 5 kg free rice have reached every village in India, but Bastar has been deprived of all these benefits because of Naxalism.

"All these benefits will reach every village in Bastar by 2030, as the pace of development in the region is set to pick up after the end of Naxalism by March 31, 2026," Mr Shah said, adding, "Naxals will no longer be allowed to disrupt peace or development in Bastar when Maoism comes to an end."

"The Narendra Modi government has given more than ₹4-lakh crores to Chhattisgarh for development works in 10 years. On behalf of the PM, I want to assure you that after March 31, 2026, Naxalites will not be able to stop your development. They will not be able to stop your rights," Shah said.

Earlier in the day, Shah paid obeisance at the shrine of Maa Danteswari, the presiding deity of Bastar, and prayed for strength for the security forces to end the red terror in the region by March 31, 2026. He hailed the





Autumn was to Keats a season of mists and mellow fruitfulness. To British hacks -- journalists -- it's the season of party conferences, which this year's so far have given prime attention and space to the issue of immigration.

The opinion polls now say that Labour's main opposition is not the Conservative Party any longer but the relatively new "national-socialist" (echoes anyone?) party called Reform, whose leader Nigel Farage uses anti-immigrant policies to rouse the rabble.

Remember Donald Trump had claimed Haitian immigrants were eating American pet cats and dogs? Mr Farage recently claimed that immigrants are eating British swans.

The agency in charge of swans says it's utter nonsense.

Of course, the main target of this anti-immigration propaganda from Nigelastika and his party, to focus the antagonisms and get some specific people within its sights, are Muslim asylum-seekers and even the resident, naturalised, passport-holding British Muslims.

That really is as absurd as claiming that the Pope is currently on Haj pilgrimage to Mecca, or even that the Pope, being American, is an ardent MAGAwalla!

But things get more and more absurd. There's a fellow called Douglas Murray who is, through his regular columns in the ultra-right-wing press, a dedicated competitor in the Swastika Stakes. This last week he published a reaction to Keir Starmer, France, Germany, Canada, Australia and now others announcing their recognition of a Palestinian state. His theory in this article was that Muslim immigrants have so infiltrated the governments of all these countries that their Prime Ministers have been coerced by Islamic force majeure of some sort to take this decision.

There is now firm evidence through the opinion polls that this nasty, lying propaganda is making an impact. Last week several public polls said that Reform was leading Labour and that could mean that Nigel Farage would, if an election was to be held now, become Britain's Prime Minister.

Labour has had to take these polls seriously -- and it has. A few weeks before their annual conference, the Labour government and Labour Party suffered two major setbacks. The Deputy PM, Angela Rayner, was tainted with the claim that she had bought a house and dodged paying tax on the transfer of funds she used to buy it. She claimed, to my mind plausibly, that it was an error of judgment as she followed what she thought was the advice she'd been given by an estate agent and not a criminal intent to dodge tax. Nevertheless, such was the outcry from the Opposition and their supporters in the press, that she thought it best for the government and party to resign, which she did.

Then there was the questioning of Keir Starmer's judgment when it was revealed that Peter Mandelson, whom he had appointed as ambassador to the United

UPSC exam needs an upgrade

The UPSC civil services

exam has steadily slipped into becoming a test of memory rather than judgement. What once rewarded depth, analysis, and the ability to argue a case has turned into a sprint through short answers, where the candidate who can reproduce facts at speed is seen as "best prepared". But in a world where search engines and AI tools can churn out information instantly, valuing recall over reasoning looks increasingly misplaced.

Governance today is not about remembering lists or definitions but about making decisions under pressure, weighing competing interests and showing the moral fibre to say no when necessary. Yet the exam's design makes it fertile ground for coaching factories, privileging formulaic answers and disadvantaging those who think differently or lack the resources to spend years in a training mill. That narrows the pool, not just socially but intellectually, at a time when the country badly needs broader perspectives.

India aspires to be a hub of digital innovation and global leadership, but its most important recruitment gateway still measures success by rote. A system that prizes quick recall over critical thought risks producing administrators better at quoting than at governing. The real test should be of how future officers handle complexity, ambiguity, and accountability, which are qualities the current format struggles to capture.

Babus love revenue, not science



But here's the irony. India's tech and innovation ecosystem is among the fastest growing in the world. We are a global hub for start-ups, AI development and digital services. Yet, at the state level, the very people meant to shepherd this growth are often indifferent placeholders. It's like asking someone who hates cricket to captain Team India; they'll show up, but don't expect runs on the board.

Mr Singh is right to call it a "mindset problem." Bureaucratic inertia, a lack of risk appetite and a blind spot for the transformative role of science are holding back momentum. What India needs are senior officers who don't see science as a punishment posting, but as the portfolio that can redefine the nation's future.

The information revolution and the rise of the Internet seemed to flatten hierarchies and give

He further stated that no previous leader of oppositions, including Indira Gandhi, Lal Krishna Advani, Atal Bihari Vajpayee, Sushma Swaraj, and Sharad Pawar, has ever made statements against the country or government while abroad.

Asked why BJP always react to Gandhi's remarks, Rijiju said, "We have nothing to do with him personally. He is LoP... If he speaks irresponsibly, we will not like it. Even Indira Gandhi ji was LoP after losing elections, but she never spoke about the country

outside and all other LoPs after her, whether it is Lal Krishna Advani, Atal Bihari Vajpayee, Sushma Swaraj, Sharad Pawar..."

"Show me one LoP who has ever gone outside India and made statements against the country or the Government. Rahul Gandhi is the first LoP who goes abroad and speaks against the country, our system and our democracy," the Union Minister asserted.

Recently, at an event at EIA University of Colombia, Rahul Gandhi took a swipe at the Narendra Modi government, asserting that the biggest challenge India is witnessing is the attack on its democracy.

"India has strong capabilities in areas like engineering and healthcare, so I am very optimistic about the country. But at the same time, there are also flaws in the structure that India has to correct. The biggest challenge is the attack on democracy taking place in India," Gandhi said.

The Congress leader argued that the democratic system remains crucial for diversity, allowing different traditions, customs, and ideas, including religious beliefs, to thrive. However, he added, the democratic system in India is under attack, which is a "major

risk" or threat.

"India has multiple religions, traditions, and languages — in fact, the country is essentially a conversation between all these people and cultures. Different traditions, religions, and ideas require space, and the best method for creating that space is the democratic system," Gandhi said.

"Currently, there is a wholesale attack on this democratic system, and that is a major risk. Another big risk is the tension between different conceptions in parts of the country. With 16-17 major languages and many religions, it is crucial to allow these diverse traditions to thrive and give them the space they need," he added.

Gandhi also attacked the RSS-BJP duo, saying that "cowardice" was at the heart of their ideology.

"This is the nature of BJP-RSS. If you notice a statement of the foreign minister, he said, 'China is much more powerful than us. How can I pick a fight with them?' At the heart of the ideology is cowardice," the Congress leader said.

The true impact lies not in these statistics alone, but in the lived experiences of families living in rural areas. This includes places where women who no longer need to walk long distances to relieve themselves: and healthier children: cleaner water bodies where wastewater and plastics are better managed and witnessing panchayats and women's groups taking local leadership in waste management.

The SBM-G program has evolved — from infrastructure to behaviour, from construction

to long-term culture. The journey from ODF to ODF Plus model has not been about ticking boxes, but about ensuring that households, schools, anganwadi centres, and public spaces reflect the success of the rural water and sanitation missions.

festivals responsibly with appropriate waste segregation systems and reduced usage of single use plastic and adoption of eco friendly sanitation facilities through the course of SHS has been a true Swachhotsav where we are not just celebrating, we are institutionalising practices, making these practices become a habit, which in time become heritage.

New Delhi: The Chief Election Commissioner (CEC) of India, Gyanesh Kumar, confirmed on Sunday October 5, 2025 that the Bihar Assembly elections will take place before November 22, 2025, when the current legislative term concludes. Bihar has a total of 243 assembly constituencies, including two reserved for Scheduled Tribes (STs) and 38 for Scheduled Castes (SCs).

Speaking at a press conference in Patna, Kumar outlined key details of the upcoming polls. "Bihar has 243 assembly constituencies – 2 for STs and 38 for SCs. The term of the Bihar Legislative Assembly ends on November 22, 2025, and

elections will be held before that time... The Election Commission trained booth-level officers for the first time... SIR was launched on June 24, 2025, and completed by the deadline..." he said, as per news agency ANI.

Revising electoral rolls before every election is lawful under the People's Representative Act, he stressed, adding that it cannot be done after the elections conclude.

Kumar urged citizens to participate enthusiastically in the elections, likening the experience to the celebration of the Chhath festival. "We congratulate the voters of India. Thank you to everyone for the successful SIR process. I appeal

to all the voters of Bihar to celebrate this festival of democracy with the same enthusiasm as you celebrate Chhath. Everyone should vote and ensure their participation," he added.

The CEC also lauded the efforts of Bihar's booth-level officers in ensuring a clean voter list, highlighting their exemplary work. "Recently, the voter list cleansing work was carried out in Bihar, and the booth-level officers present before us not only carried out the work of cleansing the voter list in their booths, but 90,217 booth-level officers of Bihar performed a work that is exemplary across the country...Just as Vaishali in Bihar showed the world the path to democracy. Together, you will become a source of inspiration for the country in the work of cleansing the voter list," Kumar said.

"Even now, there is time until ten days before the final nomination date. If any individual or political party feels that a legitimate voter is missing from the list or an ineligible voter is included, they can file their claim or objection. All claims and objections will be resolved at the ERO level. After the nomination process, the voter list will be frozen and no changes will be made until the conclusion of the election," he emphasised.

CEC Gyanesh Kumar On Aadhaar Inclusion

On inclusion of Aadhaar in the list of documents, CEC Gyanesh Kumar said, "...According to the Supreme Court's orders and under the Aadhaar Act, Aadhaar cannot be considered proof of date of birth, proof of residence, or proof of citizenship."

"The Election Commission requested Aadhaar card within the enumeration form itself. Providing your Aadhaar number is not mandatory under the Aadhaar Act, nor under Section 26 of the Representation of the People Act, 1950. It is optional. It depends on the Aadhaar holder. Even under the Aadhaar Act, the Aadhaar card is neither proof of residence nor proof of citizenship. If anyone got Aadhaar card after 2023 or downloaded it after 2023, the Aadhaar card itself, under several orders of the Supreme Court, states that the Aadhaar card

is not proof of date of birth," he added. "The Supreme Court did say, and we are following that order, that Aadhaar cards should be accepted. We were also accepting Aadhaar cards in the enumeration form and still are... However, the Supreme Court also stated in its order that the Aadhaar card will not be proof of citizenship....the Supreme Court has also stated that it is not proof of citizenship. Other documents may be required for eligibility," he further stated.

CEC Kumar On First Poll Measures Set To Begin With Bihar Election

The Election Commission has introduced several new measures to improve voter convenience and transparency. Notably, no polling station will now accommodate more than 1,200 voters. Booth-level officials will carry identification cards, while voters' mobile phones can be deposited outside polling booths. Full webcasting will be conducted at every polling station.

The CEC also announced enhancements to ballot papers: "When the ballot paper is inserted into the EVM, the photo on it is black and white, making identification difficult, although the election symbol remains. The serial number should also be larger. Starting with the Bihar elections, the serial number font

will be larger nationwide, and candidates' photographs will be in colour," he said.

Regarding vote-counting procedures, Kumar explained that mismatches between Form 17C and the EVM counting unit will now trigger careful review, and postal ballots will be counted before the final two rounds of EVM counting. Additionally, the Election Commission is gradually implementing ECI-NET, enabling citizens to access digital index cards with details of total voters and male-female participation within days after the election.

Bihar Election 2025

The electoral contest in Bihar is expected to primarily pit the ruling National Democratic Alliance (NDA), led by Chief Minister Nitish Kumar, against the Mahagathbandhan alliance, spearheaded by the Rashtriya Janata Dal (RJD). Currently, the NDA holds 131 seats in the 243-member assembly — BJP 80, JD(U) 45, HAM(S) 4, and two Independents while the Mahagathbandhan has 111 seats, comprising RJD 77, Congress 19, CPI(ML) 11, CPI(M) 2, and CPI 2. Political activity has intensified across the state, with parties ramping up campaigns and exchanging charges ahead of the high-stakes election.

20 dead as heavy rain triggers massive landslides in Darjeeling hills; Mamata to visit area on Oct 6

Darjeeling (WB): At least 20 people, including several children, were killed and scores injured as relentless downpours unleashed massive landslides across the Mirik and Darjeeling hills in West Bengal on Sunday October 5, 2025, sweeping away homes, severing road links, isolating villages, and leaving hundreds of tourists stranded, officials said.

According to reports compiled by the NDRF and the district administration, fatalities were reported from several locations Sarsaly, Jasbirgaon, Mirik Basti,
 Dhar Gaon (Mechi), Nagrakata and
 Mirik Lake area.

Stating that the loss of lives is tragic, North Bengal Development Minister Udayan Guha told PTI that the situation is "alarming."

"As of now the death toll is 20. It is likely to go up. I am on my way to the area," he said in the evening.

According to the NDRF statement, at least 11 people have died in Mirik, the worst affected area in the landslide, and seven injured have been rescued from the

area.

In Darjeeling, seven people died and the rescue operations were underway with the help of police, local administration and disaster response teams.

"Seven deaths have been reported due to a major landslide in Darjeeling subdivision triggered by heavy rainfall since last night. The rescue and relief work is on," Darjeeling Sub-Divisional Officer (SDO) Richard Lepcha told PTI.

Hundreds of tourists, who had flocked to the Darjeeling hills to

enjoy Durga Puja and post-Puja festivities, have been left stranded as heavy rainfall triggered massive landslides.

Many of them, including families and groups from Kolkata and other parts of Bengal, were visiting popular spots such as Mirik, Ghoom, and Lepchajagat when the rains lashed the hills since Saturday.

Chief Minister Mamata Banerjee announced compensation for the victims without specifying the amount and the number of deaths. She said she would visit north Bengal on October 6 to assess the situation.

Prime Minister Narendra Modi also expressed condolences over the deaths and said the situation in Darjeeling and surrounding areas is being closely monitored.

At least 40 people were rescued from debris in Dhar Gaon, Nagarakata, where heavy mudslides flattened several houses.

Leader of the Opposition Suvendu Adhikari claimed he has information that the disaster claimed 21 lives.

The landslides disrupted traffic movement on key routes, including the Mirik-Sukhiapokhri road, while communication lines to several hilltop settlements were snapped.

Speaking to TV9 Bangla news channel over the phone, the CM described the situation as "grave".

"Due to incessant rain in Bhutan, water has overflowed into North Bengal. This disaster is unfortunate – natural calamities are beyond our control. We are deeply saddened. I held virtual meetings with officials of five affected districts along with the chief secretary. I have been monitoring the situation since 6 am," she said.

According to Banerjee, more than 300 mm of rainfall occurred in just 12 hours, causing severe flooding and landslides across at least seven locations.

She compared the situation to the intense flooding that Kolkata experienced last month during the festive season.

"There has been continuous, heavy rain for 12 hours. Landslides have occurred at seven locations. I am keeping a close watch and hope to reach by around 3 pm on Monday," she said.

Thousands of tourists have been stranded across the region due to the landslides and road blockages. The CM assured them that the state government would make arrangements to bring them back safely and appealed to tourists not to panic or rush to leave.

"Many tourists are stranded. I request them not to hurry. Please stay where you are. Hotels must not overcharge them. Their safety is our responsibility, and the administration will ensure that," she said.

Banerjee also announced that the families of those killed in the disaster would receive government compensation and employment for one of their members.


A senior police officer said heavy and continuous rain has severely hampered rescue operations.

"The terrain is slippery, and several houses have been damaged. The extent of damage is still being assessed. Earthmovers are finding it extremely difficult to operate on these slopes," he said.

Several families in Mirik have been shifted to safer places as precautionary measures, while temporary relief camps have been set up in coordination with local NGOs and the district administration.

In a post on X, Modi said, "Deeply pained by the loss of lives due to a bridge mishap in Darjeeling. Condolences to those who have lost their loved ones. May the injured recover soon. The situation in Darjeeling and surrounding areas is being closely monitored in the wake of heavy rains and landslides. We are committed to providing all possible assistance to those affected."

The India Meteorological Department (IMD) has issued a red alert for extremely heavy rainfall in sub-Himalayan West Bengal, including Darjeeling and Kalimpong, till October 6, warning of more landslides and road blockages due to saturated soil conditions. According to the NDRF, road connectivity remains severely disrupted in Darjeeling district and North Sikkim, and an iron bridge connecting Siliguri with the Mirik-Darjeeling route has been damaged, cutting off access to the region.

Trump's Gaza Peace Plan: Good Start, Hurdles Loom

The crisis over Gaza, triggered by the brutal Hamas attack on Israel on October 7, 2023, has begun deescalating. On September 29, US President Donald Trump announced his 20-point plan to resolve it. With both the Israeli Cabinet and Hamas giving their approval to its contours, Phase-1 has begun.

This involves the Israeli Defence Forces (IDF) retreating to a "yellow line", skirting Gaza City etc, but well within Gaza. Hamas has agreed to release 20 hostages and hand over the remains of another 28. Israel in return must release about 250 Palestinians serving life terms and another 1722 detainees picked up from Gaza. Hamas seeks

the release of some high-profile prisoners, who can help unite Palestinians politically, across Gaza and the West Bank. So far, Israel has not accepted this demand.

Simultaneously, Israeli national security minister Itamar Ben-Gvir, representing a far-right ruling coalition party, led 1,300 illegal Israeli settlers to intrude at the Al-Aqsa mosque in Jerusalem, the third holiest Islamic site. It was condemned by Islamic nations, including Saudi Arabia, Jordan, Oatar and others. The Palestinian foreign ministry saw it as an attempt "to thwart international efforts, including President Trump's efforts, to halt the Israeli aggression and war against our

people in Gaza".

This underscores the threat to Israeli Prime Minister Benjamin Netanyahu's governing coalition from his far-right partners. Perhaps with his reputation restored, Mr Netanyahu may not fear seeking a fresh mandate.

Since the UNSC Resolution 242 (1967), followed by Resolution 338 (1973), the core principle for resolving the Israeli-Palestinian issue has been "land for security". US President Bill Clinton got Israeli prime minister Yitzhak Rabin and Palestinian leader Yasser Arafat to shake hands at the White House in September 1993. That kicked off the Oslo peace process. President Clinton's final attempt, days before his presidency ended, in December 2000 is the closest any US leader has come to resolving the lingering dispute. But once the 9/11 attacks in 2001 occurred in the United States, the global attention shifted to counter-terrorism and combating Al-Qaeda. For two decades, the Palestinian issue appeared defunct. Israeli Prime Minister Benjamin Netanyahu tactically kept Hamas, controlling Gaza, isolated from the Palestinian Authority, wielding limited powers in the West Bank. Gaza functioned like an open-air jail with its occupants granted controlled access to Israeli territory. Meanwhile, as Mr Netanyahu came under increasing pressure of criminal prosecution for alleged corruption, he aligned with the far-right political parties. Consequently, he allowed more illegal settlements in the West Bank area. Hamas' 2023 attack caught the Israeli intelligence and government off-guard. It also revived the Palestinian issue.

■ The US, under President Joe Biden, backed Israel targeting Hamas. The support persisted despite the mounting civilian massacre. Much earlier, in the early part of his first term as President, Donald Trump had announced recognition of Jerusalem as Israel's capital in December 2017. Following this, the US embassy was shifted there from Tel Aviv in May 2018. This unilateral concession, without extracting Israeli concessions, was unwise.

Following the 2023 attack, Israel began to decapitate Hezbollah and kill Hamas' top leadership, in Gaza and abroad. Once Mr Trump was back in the White House in January 2025, Israel even attacked Iranian nuclear enrichment facilities.

The US joined in bombing parts of the programme entrenched under mountains. President Trump gave Israel a free hand over six months, while his chant seeking the Nobel Peace Prize got more persistent. The Israeli air attack on the supposed location of the top Hamas leadership, negotiating a ceasefire, in Qatar boomeranged. President Trump felt embarrassed as the Qataris had snuggled up to him with a Boeing 747 gift and the continued hosting of a US military base.

This was the last straw which motivated the US to seek an end to Israel's Gaza operation. However, the next steps can be extremely challenging. First, the demilitarisation of Gaza and disarming of Hamas. Second, having Hamas abandon power, which it has wielded since 2007. Its surviving fighters must also opt for exile or amnesty. Finally, the issue of transitional government, consisting of select Palestinians and experts.

Overseeing that would be another body, led by President Trump, called the "Board of Peace". The composition of these bodies and the methodology to disarm Hamas are unclear. Meanwhile, the Nobel Peace Prize has gone to a Venezuelan pro-democracy activist, Maria Corina Machado.

She shrewdly dedicated her award to President Trump. She is now in hiding and requires the US pressure on the Venezuelan government to institute democratic reforms and free elections. According to Alfred Nobel the award is to be bestowed on a person, who during the preceding year conferred "the greatest benefit on mankind".

Targeting The Ugly Indian: New India Myth Justified?

Picture the scene. A street in some picturesque European town. People chatting, drinking wine or coffee, eating, shopping, milling around. Suddenly, a long sharp sweet note from a flute rises and falls. Other instruments join in. People look around, and watch as musicians fill the street and the windows above. Strains of Mozart rise to a crescendo, matched by the

awe and wonder of the people who realise they are part of a flash mob.

This to many is a sign of shared civilisation. Shared beauty and experience, a drop of joy in a mundane world.

Here's another scene. La Tomatina or the tomato festival in Spain where people throw tomatoes at each other in the streets of Bunol. It used to be a free-for-all with no limits on participants. Now it's a ticketed event limited to 20,000 people. Suddenly, a group of Indians break into a happy Garba dance, weaving through the crowds in streets red with tomato pulp.

This impromptu dance is not seen as a sign of joy and an expression of culture by some Indians. It is seen as a brash

imposition of an alien culture, too much chilli in this tomato soup. I do not know how the other participants view the dance.

But I have heard that foreigners will pay money to be part of a big fat Indian Bollywood wedding. The Internet is flooded with videos and images of Indians "misbehaving", in India and in other lands. Some of the comments are full of pride and others are full of anger and shame. Both for the same behaviour.

Have we become worse in the way we behave, both within and outside India? Are we more entitled, less aware of those around us, less considerate, more brash?

Or are we falling prey to a reverse racism, where we are so desperate for Western or white acceptance that we are unable to celebrate our own joy?

explanations Several exist for this behaviour. And some justifications. There is possibly a mass fear that if you do not jump up and stand in a line with your bags in hand before the plane lands, you may never get off. It is also possible that everyone one of those 200 people has an emergency that requires they get out of the plane immediately. Some look at criticism of this behaviour as a class thing - that people who once travelled by train, now travel by air and if you don't like how they behave you are a classist git and twit. However, it is also true that I cannot lie. The loud, obnoxious, entitled behaviour of some Indians, in India and elsewhere, can be unbearable. The most annoying to me is the totally inexplicable and dangerous need to jump out of your seat before a plane lands, just to get your cases out of the holds. You ignore the crew begging you to sit down. You ignore warnings that it is dangerous. You are lost in some world where if you do not stand up now, you may never leave the plane. Never mind the danger you place yourself and others in. After this mad rush, you jam yourselves into a queue in the aisle of the plane for 10 minutes, while it lands, taxis, docks, doors open and so on.

the people who behave like this are of all social classes. So, is it entitlement of a new India? This reasoning began when talented cricketers emerged out of smalltown India and it seemed to some city folk that they were far too boisterous in their celebrations because small town folk are like that. Other said that it was classist to think like that, because the rules of small-town India were now the rules of India itself. A certain amount of political misbehaviour also uses this excuse. Yet, how real is this reasoning? It is, for the most part, the middle classes of India that behave with the most entitlement. Whether it's with how they drive or show off or ignore and flout local customs whether in India or abroad. Perhaps I should separate loud noises from all arguments because being noisy appears to be a trait that is integral to our psyche. We have to scream top volume whenever we can and very often when we should not. Indian tourists are increasingly unwelcome in different places,

because of the lack of respect for Goa and Uttarakhand others. are fed up with tourist behaviour, even if they need the money from tourism. Thailand is similarly wary of large groups of Indians and this makes life difficult for Indians who try to follow local rules and customs. Much of the internal anger comes from law-abiding Indians, which is a small but vocal category. However, I am torn between all the arguments, for and against. I do not for instance agree that poor and small-town Indians behave badly as a matter of course, because they do not understand Western societal standards. I do not agree that poor and smalltown Indians behave badly at all. The worst behaviour comes from the middle classes, from people with new money and from some sort of natural exuberance at being able to do all these things denied to them before. The worst vulgarity happens when the rich celebrate massive weddings, massive fireworks displays at Diwali and so on.

Party names 41 district election observers as part of its Bihar poll strategy New Delhi: The Congress on Saturday October 4, 2025 appointed former chief ministers Ashok Gehlot, Bhupesh Baghel, and ex-Congress leader in Lok Sabha, Adhir Ranjan Chowdhury, as senior observers for the upcoming Bihar Assembly elections. "The Congress president (Mallikarjun Kharge) has appointed the following leaders as AICC senior observers for the upcoming Assembly elections in Bihar with immediate effect — Ashok Gehlot, Bhupesh Baghel and Adhir Ranjan Chowdhury.

The Congress president

has also approved a proposal for the appointment of district election observers, as enclosed, for the upcoming Assembly elections in Bihar, with immediate effect, AICC general secretary K C Venugopal said in a statement.

The Congress chief has appointed a set of 41 leaders from across the country as election observers in every district of the state. Bihar elections are slated later this year and the Congress is leaving no stone unturned to return to power in the state alongwith its allies by ousting the ruling NDA.
